To all Vendors,

Booth space is now available for the 2009 Montezuma County Fair July 29th - August 1st.

We have a new layout for the vendor area as well as larger spaces! Livestock shows and exhibits are open to the public starting July 29th. The theme for the Fair this year is "Friends, Family & Fun". In addition to the shows there will be demonstrations, lectures, and games. The Corn shucking contest is back as well as the Ranch Rodeo, Chuckwagon Dinner, Junior Livestock Sale, Demolition Derby and the Country Gold Concert. This year LeRoy Vandyke is presenting, Moe Bandy, Charlie Rich Jr. and Barbara Fairchild.

The Montezuma County Fair accepts any Individual, Business or Organization as a vendor. Simply fill out the application on the reverse and return it with payment by June 20th. After June 20th payment must be made by cash or money order only, checks will not be accepted. Booth spaces are assigned when applications with payment are received. Booth space will not be reserved without payment. Booth space this year is 14x14 please specify if you need electricity. Vendors are to bring their own displays, as the Fair **does not** provide tables.

All Food Vendors will be outside of the Main Barn in the Food Court area. Only one Food Vendor of each type will be accepted.

Set up begins Wednesday July 29th at 9:00am. Please check-in before you set up. You may tear down your booth Saturday August 1st once the crowd disperses after the Junior Livestock Sale, approximately 4pm.

- *Applications with payment will be assigned booth space on a first come first serve basis. All Booth placements are final. Vendor must bring own display materials. No tables provided.
- *Set up Wednesday July 29th 9-12. Tear down Saturday August 1st approx. 4pm. Vendors are expected to stay thru entire Fair. Failure to do so will result in forfeiture of exhibition right in future Fairs.
- * Booths must be open and staffed daily from 9-9 during the duration of the Fair.
- *Security will be provided. However you are advised to secure your booth before leaving for the night.
- *Montezuma County Fair is not responsible for loss due to theft or damage.
- * *Cancellations before June 20th will be refunded in full less a \$25 processing fee. There will be no refunds for cancellations after June 20th.*
- *Please make a copy of this agreement for your records

Liability Release: It is agreed by the parties that the nature of the facilities, the presence and circulation of large numbers of people and the large number of removable articles in numerous booths make it reasonable that: the exhibitor shall assume the risk of injury, loss or damage; and the exhibitor signing of the contract hereby assumes such risk and releases the Montezuma County Fairboard from any and all claims for loss, damage and injury.
